NOTICE TO PLAYERS

Play is governed by the Rules of Golf Effective January 2023 and the AJGA Tournament Hard Card. **Disregard any local rules on The Havens Country Club scorecard or any other posted local rules.** In addition, the following specific rules apply:

1. **FORMAT:** 18 holes of stroke play. The competition will not extend beyond Monday, July 20, 2026.
2. **PLAYOFFS:** All playoffs for the final qualifying spots will proceed from the No. 10 tee.
 - A playoff for the Girls Division will begin at 2:15 p.m.
 - A playoff for the Boys Division will begin at 2:30 p.m.**NOTE:** If play is delayed for any reason the starting time for the qualifier playoff will also be delayed. If applicable, this will be communicated to players on-site.
3. **TOURNAMENT TEES:** **Boys** will be playing from the **BLACK** tees.
 Girls will be playing from the **RED** tees.
4. **PRACTICE FACILITIES:** The following areas at The Havens Country Club are designated as practice facilities and can be used by AJGA participants: The practice putting green, the driving range and the short game area. The driving range and short game area will not be available after play. Practice facilities not listed are closed to AJGA participants.
5. **OUT OF BOUNDS:** Out of bounds is defined by inside edge of roads, white stakes, property fence posts or walls at ground level. When defined by a white line the line itself is out of bounds. Out of Bounds also includes the following:
 - **Out of Bounds on No. 1 is defined by outside edge of the cart path.** The white line on the cart path identifies out of bounds.
 - White discs located on cart paths on Nos. 1, 9, 12, 14, and 18 identify Out of Bounds. Out of bounds is defined by the edge of the cart path nearest the white discs.
6. **NO PLAY ZONE – RED PENALTY AREA:** If a player's ball lies in the red penalty area defined as a No Play Zone to the left & behind No. 18 green which is identified by red stakes with blue tops the player **MUST** take relief in accordance with Rule 17.1e under a penalty of one stroke. If a player's ball lies outside a red penalty area defined as a No Play Zone, but has interference with their area of intended stance or area of intended swing from the No Play Zone the player **MUST** take free relief in accordance with Rule 16.1f(2).
7. **AGJA DROPPING ZONES**
 - **CART PATH (No. 12):** If a ball comes to rest on the cart path and is located within the four blue stakes right of No. 12 green the player has these free relief options:
 - Take relief under Rule 16.1
 - As an extra option, drop the original ball or another ball in the dropping zone located near the cart path. The dropping zone is a relief area under Rule 14
 - **PENALTY AREA (Nos. 6 & 10):** If a ball is in the red penalty area on the right side of Hole No. 6 green or in front of No. 10 green, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke:
 - Take relief under Rule 17.1, or
 - As an extra option, drop the original ball or another ball in the dropping zone that is located in front right of the green on No. 6 or in front left of the RPA on No.10. The dropping zone is a relief area under Rule 14.3.
8. **INTEGRAL OBJECTS:** The rock wall and cobblestone paver areas around the golf course are integral objects and no free relief is available.
9. **FADED LINES:** Disregard all faded ground under repair and penalty area lines. Players must use freshly painted lines.
10. **ADVICE: (Rule 10.2a)** is any verbal comment or action that is intended to influence a player in choosing a club, making a stroke or deciding how to play during a hole or round. In addition, any conversation between player/spectator may be construed as advice. This includes any conversation between player/spectator in their native language. In either instance penalty for breach of this rule is two strokes. Players are responsible for the actions of their relatives and spectators in regards to this rule.
11. **COMMITTEE:** The Committee, as defined in the Rules of Golf, consists of the senior rules official, all AJGA staff members present during competition, and any guest rules officials appointed by the tournament director. The Tournament Rules Committee composed of Senior Rules Official Ed Pernal, Tournament Director Jayce Carsten, and Tournament Assistant Matthew Niemela, will have final decision-making authority over all rules-related matters.
