NOTICE TO PLAYERS

Play is governed by the Rules of Golf Effective January 2023 and the AJGA Tournament Hard Card. **Disregard any local rules on the Bella Collina San Clemente – Carnoustie & Muirfield scorecard or any other posted local rules.** In addition, the following specific rules apply:

1. **FORMAT**: 18 holes of stroke play. The competition will not extend beyond Saturday, August 9, 2025.
2. **PLAYOFFS**: All playoffs for the final qualifying spots will proceed from the Carnoustie No. 1 tee.
 - A playoff for the Girls Division will begin at 7:15 p.m.
 - A playoff for the Boys Division will begin at 7:30 p.m.

NOTE: If play is delayed for any reason the starting time for the qualifier playoff will also be delayed. If applicable, this will be communicated to players on-site. If there is not enough daylight to complete the playoff, ties will be determined by a scorecard playoff.
3. **TOURNAMENT TEES**: **Boys** will be playing from the **BLUE** tees.
Girls will be playing from the **WHITE** tees.
4. **PRACTICE FACILITIES**: The following areas at Bella Collina San Clemente are designated as practice facilities and can be used by AJGA participants: The practice putting greens, the driving range and the short game area. Practice facilities not listed are closed to AJGA participants.
5. **GROUND UNDER REPAIR (BLUE PAINT)**: Ground under repair is defined by painted **BLUE** lines.

NOTE: Please disregard all painted white lines, these have no bearing on the competition and should be ignored.
6. **OUT OF BOUNDS**: Defined by white stakes, white stakes with black tops, and perimeter/public road curbing. In these circumstances, the boundary edge is defined by the line between the course-side points of the stakes and curbing at ground level.

NOTE: A ball that crosses any public road that is defined as out of bounds is out of bounds, even if it comes to rest on another part of the course (Model Local Rule A-3).
7. **AJGA DROPPING ZONE (YELLOW PENALTY AREA)**: If a ball is in the yellow penalty area in front of No. 8 green, including when it is known or virtually certain that a ball has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke:
 - Take relief under Rule 17.1, or
 - As an extra option, drop the original ball or another ball in the dropping zone painted in blue paint located on a forward teeing location. The dropping zone is a relief area under Rule 14.3.
8. **RED PENALTY AREA**: Red penalty areas are defined by painted red lines. In the absence of paint lines, penalty areas are defined by the outside points of stakes at ground level. These stakes are also part of the penalty area. Red penalty areas are also defined by:
 - When tied into a cart path, the edge of the cart path defines the penalty area. Red dots are present to identify the red penalty area.
 - The painted red line on the cart path left of No. 10 fairway.
9. **FADED LINES**: Disregard all faded ground under repair and penalty area lines. Players must use freshly painted lines.
10. **ADVICE: (Rule 10.2a)** is any verbal comment or action that is intended to influence a player in choosing a club, making a stroke or deciding how to play during a hole or round. In addition, any conversation between player/spectator may be construed as advice. This includes any conversation between player/spectator in their native language. In either instance penalty for breach of this rule is two strokes. Players are responsible for the actions of their relatives and spectators in regards to this rule.
11. **COMMITTEE**: The Committee, as defined in the Rules of Golf, consists of the senior rules official, all AJGA staff members present during competition, and any guest rules officials appointed by the tournament director. The Tournament Rules Committee composed of Senior Rules Official Ed Pernal, Tournament Director Jacob Kennedy, and Regional Manager Jordan Alejandre, will have final decision-making authority over all rules-related matters.
